As an example, if you accepted the full amount of your \$20,500 Direct Unsubsidized loan for the 2017-18 academic year, the fall portion is \$10,250. Once the 1.069% fee is deducted (or \$109.00—we round down), \$10,141 will actually disburse to your DU student account on August 4th.

Disbursement and Repayment. Disbursements to student accounts typically occur on the first day of each week. Any credit balance can be expected to be refunded within three (3) business days. Students who withdraw after the 60% Point are not required to return federal financial aid funds.
