An Affidavit of Consent and Support is used when a minor child is applying for a passport or travelling with a person other than his or her parent(s), legal guardian or person exercising parental authority/legal custody over him or her. If the child is an illegitimate child, it is also needed when he or she is travelling with his/her biological father.
