Confidentiality Agreement And Agency Disclosure

A confidentiality agreement (also called a nondisclosure agreement or NDA) is a legally binding contract in which a person or business promises to treat specific information as a trade secret and promises not to disclose the secret to others without proper authorization. An example of a typical confidentiality agreement (NDA) is provided below.

Sample Confidentiality Agreement (NDA)

There are two main formats for confidentiality agreement templates - a one-sided agreement and a mutual agreement. The first one is when you think that only one party will share confidential information with the other party whereas the second one is for situations where each of the parties may share sensitive or confidential information.
