Mail orderlies will be designated on enclosure (3) and DD Form 285, Appointment of Mail Orderly. Designated personnel are required to carry their cards and a valid identification card while performing mail-handling duties and to present the card when receiving mail. DD Form 285 must be strictly accounted for and used only by designated personnel.

DD Form 285, Appointment of Military Postal Clerk, Unit ...

DD Form 285, Appointment of Military Postal Clerk, Unit Mail Clerk or Mail Orderly is a form used to designate military postal clerks, unit mail clerks or mail orderlies and identify the mail they are authorized to pick up and deliver. The mailing orderly has to receive proper job training and instructions prior to assuming their duties.
