Whereas the homebound status may just say "homebound due to SOB with minimal exertion." In the same manner, "unstable blood sugars" is a valid homebound status for diabetes out of control, but it is further strengthened by documentation. "FBS 250 without symptoms. The frequency of this documentation is completely dependent on each patient. For example, a patient who is suffering from a chronic, debilitating illness that is not expected to chance may only need this documentation ...
