#### M39-A - Analysis and Presentation of Cumulative ...

The document, "Methods for Antimicrobial Dilution and Disk Susceptibility Testing of Infrequently Isolated or Fastidious Bacteria," was published as an approved guideline (M45-A) in May 2006 and represents a consensus approach to standardized antimicrobial susceptibility testing of 14 genera, species, or organism groups of uncommon or fastidious bacteria.

### Use of the National Committee for Clinical Laboratory ...

Susceptibility testing is particularly necessary in those situations where the etiologic agent belongs to a bacterial species for which resistance to commonly used antimicrobial agents has

been documented, or could arise. A variety of laboratory techniques can be used to measure the in vitro susceptibility of bacteria to antimicrobial agents.

### Nccls guidelines for antimicrobial susceptibility testing ...

The NCCLS Antimicrobial Susceptibility Testing subcommittee has approved QC ranges for ciprofloxacin . Ciprofloxacin is intended for human medical use, and while it may sometimes be used in companion animal medicine under extralabel provisions, its use in food animals is strictly prohibited by the U.S. Food and Drug Administration's Center for Veterinary Medicine.

#### New Consensus Guidelines from the Clinical and Laboratory ...

Antimicrobial susceptibility testing. All isolates were screened for ESBLs by BMD using NCCLS guidelines . MIC plates containing eight twofold dilutions of CAZ, CTX, ceftriaxone (CRO), aztreonam
